NOTICE TO EXHIBITORS

1. The Trial will held under AAC Rules and Regulations, outside on a grass surface. No provisions have been made for rain or sun. Bring your chair and protection from the weather for yourself and your dog.
2. Please do not litter. Use the designated area for your dog, and then clean up. Dogs must be on leash at all times except in the warm up area and on the course.
3. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of AAC Rules and Regulations as well as those for the Junior Handler Program. No collar, food or other device will be allowed on the course.
4. The Trial Organizing Committee reserves the right to refuse any entry. Disciplinary problems will be submitted and reviewed by the AAC Disciplinary Committee.
5. All dogs must have an AAC ID No. and card in order to compete in AAC events.
6. Competitors participate in this event at their own risk. The release form must be signed in order to comply with AAC's registration requirements.
7. No entries may be accepted, altered, cancelled or substituted after the closing date.
8. There shall be no refunds in the event that the dog is absent on the day of the trial, or if the dog/handler is dismissed from competition, regardless of the reason for such dismissal, or in the event of inclement weather, other than as provided for below.
9. Dogs in season are not permitted to compete. When a dog comes into season after the entry has been submitted, a refund will be made on submission of a veterinary certificate prior to the day of the trial, certifying that the dog was in season within the 12 day period preceding the trial.
10. When a dog has become injured after the entry has been submitted, a refund will be made on submission of a veterinary certificate prior to the day of the trial, certifying that the dog has sustained injury.
11. Electronic timing will be used.
12. Junior handlers must have an identification number. A dog registered in junior handler classes may not do the same course twice. The new rules allow a junior handler to compete in all classes (including games) at the same AAC trial.
13. All jumps are plastic or wood, are winged and 2 pieces.
14. All contacts are rubberized.

SCHEDULE OF EVENTS

There will be no familiarization period.

2 jumps will be available for warm-up purposes.

Your dog must have a new AAC Identity Card effective January 1, 2018, with new measurements. All competitors must show their new card at the registration desk.

DESCRIPTION OF CLASSES

Starters Standard: For dogs that have not earned the ADC title.

Starters Games: For dogs that have not yet earned two qualifying scores in the game in question

Advanced Standard: For dogs that have earned an ADC title but have not earned the AADC title.

Advanced Games: For dogs that have earned two qualifying scores in the Starters game in question.

Masters Standard: For dogs that have earned an AADC title.

Masters Games: For dogs that have earned three qualifying scores at the Advanced level for the game in question.

Veteran Classes: Open to dogs 7 yrs. or over at all levels, and dogs 5 yrs. or over that have been competing in the Special classes for a minimum of one calendar year. Veterans compete at one jump height lower than their regular height. Double drop veterans compete two jump heights lower than their regular height.

Special Classes: Handlers running a dog in Specials will have the option to move into Regular classes once during the dog's career. Such a switch will require the handler to notify the AAC via the appropriate Regional Director, but will not require application or approval. A switch from Specials to Regular cannot be made mid-trial.

ROSETTES & RIBBONS

Q rosettes and placement ribbons will be available on a self-serve basis.

Ribbons from 1st to 4th place in each height division for all categories. All dogs with a qualifying score earn a rosette. A Club Agilité Canin de St-Lazare special rosette will be awarded for an AAC title of any level achieved at this trial and will be presented in the ring.

MOVE-UPS

Move-ups will not be permitted during the trial. A dog earning a title after the closing date may advance to a higher level providing the Trial Secretary is notified by 7:00 pm Monday June 25th, 2018.

OBSTACLES

All obstacles will conform to AAC specifications. All contacts are rubberized. Only 2 piece jumps will be used.

Agility Association of Canada ("AAC") - Participation waiver and Release

In consideration of the acceptance of this entry by AAC and Club d'Agilité Canin de St. Lazare (the "Organizing Club") and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the "Event"), I, the undersigned, agree as follows:

- I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
- I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
- I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the "Personnel") for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
- I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and hold harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers' fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to: (a) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or (b) aggressive behaviour by the Dog or any other dog under my control.
- I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the "Rules"). I agree to abide by the Rules and to conduct myself and the Dog in accordance with the Rules. I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.
- I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information.
- I have been given the opportunity to read and understand the terms of this Agreement before signing it, and have in fact done so. I understand that by signing this Agreement, I am restricting my legal rights and I sign this Agreement voluntarily and of my own free will.
